Mariposa County 4-H Policies

- The 4-H club year in Mariposa is October 1-Sept. 30
- Members may transfer clubs only once during the program year
- Re-enrolled members must be enrolled in a project by October 1 and new members by November 1 for 2012 fairs. Can change or add projects by December 15
- Each club must send the Community Club Leader and project leaders to the CCL /Project leader Workshops
- New leaders must attend an orientation, be fingerprinted and be approved by County Director before having project meetings
- ◆ Section 800 'Child Safety Policy'— all projects Must have two certified volunteer leaders or either one certified volunteer leader and a parent at each project meeting.

- There must be a minimum of six one hour meetings with a minimum of 10 hours of instruction for <u>all</u> projects during the program year
- Clubs must submit budget/planning & constitution/by-laws by November 15 to the UCCE Office for approval
- Clubs Community Club Leader must submit an All Reasonable Efforts form along with flyers, photos, etc. by September 30 to the office.
- Members must maintain 80% attendance requirement at club & project meetings, do a presentation in front of their project group by July 15 & have their project record form & PDR current to show at fair. Completed record books due to CCL at their September club meeting or required date.
- A member may visit another

- club only twice during the program year. The member must have the 'interclub slip' signed by visiting Community Club Leader and taken to own CCL to receive credit for that meeting
- ◆ Uniform to be worn at 4-H events and fairs is *Dark* blue jeans, white blouse/shirt with sleeves and tucked in, 4-H hat, scarf or tie. For competition, a belt matching the color of shoes is encouraged.
- ◆ If members decide to transfer from 4-H to either independent or FFA, they MUST complete the "Livestock Project Transfer Form" & turn into the UCCE office 60 or more days before fair for all projects or 120 days for beef. This is a requirement to sell at 2012 fairs.
- ◆ Copy of the CDFA Agreement between 4-H, FFA, Grange and Fairs available at the office.

They have titles like forest pathologist, soil scientist, forestry consultant, recreation coordinator, forest supervisor, wood chemist, wilderness and trails specialist, wildlife biologist and habitat specialist, education specialist, and timberland investor. Foresters and natural resource professionals are everywhere -- enjoying the outdoors, working in a lab or classroom, using technology, talking with local communities and landowners, and speaking in public. Park Ranger

Park Rangers perform a wide variety of duties in managing parks, historical sites, and recreational areas. Many wear a prescribed uniform.

Park Rangers supervise, manage and perform work in the conservation and use of resources in national parks and other federally-managed areas. Park Rangers carry out various tasks associated with forest or structural fire control; protection of property; gathering and dissemination of natural, historical. or scientific information; development of interpretive material for the natural, historical, or cultural features of an era: demonstration of folk art and crafts; enforcement of laws and regulations; investigation of violations, complaints, trespass/encroachment, and accidents; search and rescue; and management of historical, cultural, and natural resources, such as wildlife, forests, lakeshores, seashores, historic buildings, battlefields, archaeological properties, and recreation areas. They also operate campgrounds, including such tasks as assigning sites, replenishing firewood, performing safety inspections, providing information to visitors, and leading guided tours. Differences in the exact nature of duties depend on the grade of position, the site's size and specific needs

4-H Projects Criteria

In the next few months the 4-H Spirit will offer 4-H leader's criteria for their projects such as leaders names, meeting location, needs for project etc. to help members and parents get started.

Besides the project criteria, all members must have 80% attendance at club and project meetings, must complete project record form and Personal Development Form (PDR), and do a project presentation per project that member is in. These records are to be current and up-to-date by July 15 for fair purposes and then completed and turned in at the September club meeting or by the required date set by 4-H Staff.

County-Wide Horse & Pony Project... What's it all about?

Leader: Carol Suggs

You can expect to learn about sportsmanship, horsemanship, safety and basic horse handling skills and have fun!

This project does not teach any specific discipline of riding. It doesn't matter which style of riding that you do. Instead we focus on the fundamentals of horsemanship, safety and sportsmanship in all disciplines of riding.

When we are not riding we are learning about horse related subjects. We set goals at the beginning of the year and will work with you to achieve those goals.

Don't have a horse? That is ok. Many of our members lease or borrow horses. Although there is not a requirement to have a horse for this project there is some riding and horse handling skill requirements and you will need to speak to the leader to see if she has an appropriate horse for you to borrow for practice and for your skills testing.

Although we may only have 7 required meetings a year we offer upwards of 15 meetings a year for members. We also attend local horse shows and 4-H events and take field trips when possible.

Meetings without our horses are typically held at the 4-H office while meetings that involve riding or horse handling are held at Silver Valley Ranch, which is an approved 4-H facility with UC Davis.

Helmets and appropriate riding attire are always required when riding at a 4-H meeting or at a sanctioned 4-H event. Helmets to borrow are available at the 4-H office.

Besides normal county requirements for passing a project we have a few special requirements for our project. A level riding and written test is to be passed with an 80% scoring or better

along with at least 3 hours of volunteerism at an approved horse related event. First year members are to watch a safety video and a showmanship video

Cake Decorating

This project is county-wide and is for regular members only and limited to 12 members.

There will be 6 regular meetings and 2 to 3 elective meetings held either at the 4-H office or at the leader's home. Members will learn how to frost and border a cake, learn how to decorate cakes for various occasions. Members will be required to bring a cake and frosting to each meeting and also required to purchase 2 different cake pans, as well as some cake decorating supplies.

Hi 4-H

Leaders-Beth Broomfield & Donna Wice

This project is for 7th-12th grade members and held the first Monday of each month at 4p at the 4-H Office.

Members do community service, have guest speakers, fundraisers, visit colleges, and go on end-of-year trip.

Requirements are members to participate 80% of Hi 4-H activities, fundraisers to attend the end-of-year trip.

- National 4-H Council has announced the annual Youth in Action awards opportunity. - ◆ "Save the Date!" The 2012 California 4-H Camping Conference will be held March 23 25th, 2012 at Camp Campbell in Boulder Creek, CA. There will be hands-on training for adult and teen leaders who help plan and administer 4-H camping programs. More details will follow in the next edition of Updates.
- The State 4-H Fashion Revue committee announces categories and service projects for 2012! Entry categories returning from 2011 will be Traditional, Consumer Science Purchased (with \$100 limit), and Wearable Art-Embellished. The Recycled category will not be offered at State Fashion Revue for 2012; counties may choose to include it at local events only. The \$15 Challenge was so popular in 2011, it will become the \$19.99 Challenge for 2012. It has the same rules (shoes and sales tax don't count, receipts required) but the limit is increased to \$19.99 to allow more creativity. We are adding a second challenge, called the Bag Up Fashion Challenge. Sew a tote bag from Simplicity #7161, view A only, and model it with a garment or garments that coordinate with the tote bag. SFR will be coordinating two service projects. The Quilts for Wounded Warriors is returning because the American Legion needs more quilts. Statewide, 4-H created sixty quilts in 2011 and we look forward to even more in 2012. Our second service activity is the Million Pillowcase Project, for handmade or decorated pillowcases. The 2010-11 year has ended and all record books should have been turned in to your Community Club Leaders. All record books should have been handed in to your CCL by September 20 to be eligible for county awards. All records books must be turned in by September 30th to complete this project year and to receive your stripe and year pin and to be eligible for 2012 fairs.

The new program year will begin October 1st and it is time once again to keep track of your 4-H activities. The easiest way to keep track is using a calendar. Place a calendar in your bedroom and every time you attend a 4-H activity, go to a project meeting, etc., write it down on your calendar and then transfer it over to your PDR as the year goes on. Don't wait to do your project record forms and PDR at the last minute. If you plan on trying to earn a county award, remember to use ink or type your forms.
